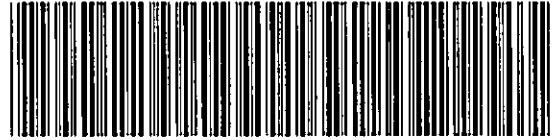



JACK COSCIA'S RESIGNATION


