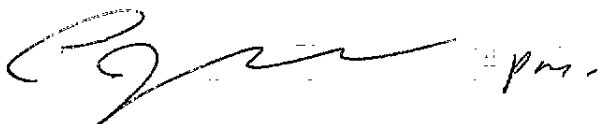

The name of the corporation shall be: DRYCLEAN 2000, Inc.

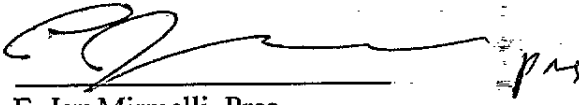
**SECOND:** The amendment is adopted on December 17, 1999.
