Certificate of Articles of Incorporation

of

VITART, INC.

I, the undersigned, hereby enter into this Certificate of The Articles of Incorporation for the purpose of becoming a corporation of under the laws of the State of Florida, and by and under the provisions of the statutes of the State providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be VITART, INC.

The general nature of the business to be transacted by this corporation is as follows:
