ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally to practice the profession of attorney in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act. and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I: NAME

The name of the corporation is Sheila D. Turner, P.A.

ARTICLE II: PURPOSE AND NATURE OF BUSINESS

The purpose of the corporation of its business are as follows:

1. To practice the profession of Law as a professional service corporation in the Courts of the State of Florida, the United States, and elsewhere, and to render such services as are ancillary to the practice of law, all in accordance with the Rules regulating the Florida Bar and the Rules of Professional Conduct contained therein.

2. To generally engage in and carry on any business incidental thereto; to do any and all other things and to exercise any and all other powers which a Florida professional legal service corporation, by authority and by law, does or exercises; to construct, lease, purchase or otherwise acquire real estate and personal property of any nature, or any interest, therein, without limit as to the amount or value, reasonably necessary or convenient for effecting or furthering any or all of the powers, including, ownership of real estate, intangible property, entering into contracts or incidental to the accomplishment or furtherance of the purpose of the Corporation, all in accordance with the provisions of F.S. Chapter 621.

3. The services of this Corporation which consist of the practice of law shall be carried out only through officers, employees and agents who are active members of the Florida Bar, in good standing and licensed in Florida to render the services of attorney or counselor of law.

4. To do any and all things and exercise any and all power necessary, proper, convenient or advisable to accomplish one or more of the purposes of the Corporation, or which shall at any time appear to be for the benefit of the Corporation in connection therewith for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which may or hereafter be lawful for the Corporation to exercise under laws of the State of Florida, the

Professional Rules of Conduct or the provisions of the Articles of Incorporation.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at one time is 100 shares having a par value of \$1.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to practice law in the State of Florida and is an active member of the law in good standing.

ARTICLE IV: DURATION

The corporation shall have a perpetual existence.

ARTICLE V: ADDRESS AND AGENT

The street address of the principal and initial registered office of the Corporation is 2100 Dr. Martin Luther King, Jr. Street South, St Petersburg, Florida 33705, and the name of the initial registered agent is SHEILA D. TURNER, ESQ. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent

ARTICLES VI: DIRECTORS

The Corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice law and is an active member of the Florida Bar in good standing. The Directors shall be elected by the shareholders of the Corporation. The name and street address of the person who is to serve as a member of the initial Board of Directors is as follows:

ARTICLE VII: SUBSCRIBERS

ARTICLE VIII: RESTRAINT ON ALIENATION

No shareholder may sell or transfer any of his or her shares in the Corporation except to another

individual who is eligible to be a shareholder of the Corporation under Florida law.

ARTICLE IX: DISQUALIFICATION

If any officer, shareholder, agent or employee of the Corporation who has been rendering professional service to the public for the Corporation becomes legally disqualified to render such professional services within Florida or accepts employment that places restrictions or limitations upon his or her continued rendering of such professional services, then the Corporation shall require him or her to comply with the Florida Professional Service Corporation Act by serving all employment with and financial interests in the Corporation.

ARTICLE X: AMENDMENT

The Article of Incorporation may be amended in the manner provided by law.




