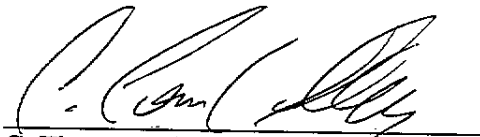
1. The name of the corporation before amendment was EPI XVII, INC.
