PURPOSE

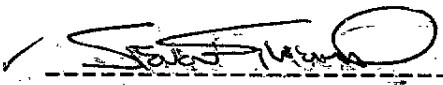

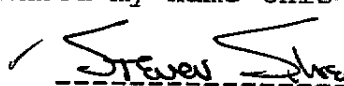

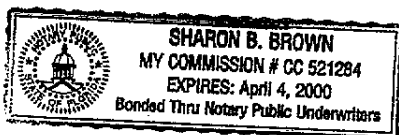
