Trespectfully request that you reinstate the above referenced corporation without the penalty charge, that is for \$300:00 paying for Uniform Business Reports for years 1999 and 2000. We are attaching the check.

We base our request on the following REASONABLE CAUSES:

- 1/ Our corporation was established in 1999 and the year 2000 Uniform Business Report was the first one that we were supposed to file. We did not know about this requirement.
- 2/ For reason unknown to us, we never received the original Uniform Business Report, when other corporations got it. We also never received the Second Notice that your Department mails in May/June. Furthermore we were never notified about the Administrative Dissolution, that took place in September 2000.
- 3/ We would never know that our corporation has been dissolved, if not for our accountant who has verified the status of all his clients' corporations on INTERNET in late December. He sent out letters to all clients that had a problem and that is how we found out that we had a problem. He also let us know when we were supposed to get your forms.

Our accountant is Michael D. Pasek at Tax Centers Inc. and his telephone number is 727-544-2796. He can confirm that our statement is true.

4/Last but not least, we are a small business operated by one person (sole shareholder). The corporation does not own anything and it operates a home for the elderly with a capacity for 9 persons, but with only 4 residents at this time. We are struggling financially. We do not have an accounting department of our own, responsible for all government filings. We cannot afford to pay \$600 penalty
