ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is, **PUBLIC BEACH, INC.**

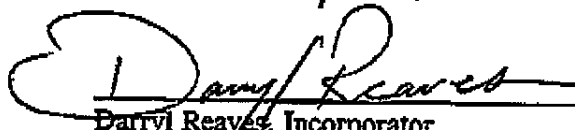
