ARTICLES OF INCORPORATION

Of

Get Real Holding Corporation

Adopted November 3, 1999

ARTICLE I NAME

The name of the Corporation shall be Get Real Holding Corporation. The Corporation may employ other trade names as the Board of Directors may designate or as the business of the Corporation may require from time to time.

ARTICLE II OFFICES

The principal office of the Corporation in the State of Florida shall be located at 10081 Paradise Boulevard, St. Petersburg, County of Pinellas, Florida 33706. The mailing address of the Corporation shall be P.O. Box 66715, St. Petersburg, Florida 33706. The Corporation may have such other offices or mailing addresses, either within or without the State of Florida, as the Board of Directors may designate or as the business of the Corporation may require from time to time.

ARTICLE III SHARES

SECTION 1. Number of Shares. No more than one thousand (1,000) shares of common stock are authorized to be issued under this plan, such stock to have a par value of one thousandth of a dollar (\$.001) per share.
