ARTICLES OF INCORPORATION OF WINDS OF ADVENTURE, INC.

SCORING WILLS The undersigned, being of legal age and desiring to form a corporation (herein referred to as the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act"), executes the following Articles of Incorporation.

ARTICLE I

Name

The name of the Corporation shall be WINDS OF ADVENTURE, INC.

ARTICLE II

Initial Registered Office and Agent; Principal Place of Business

The principal place of business and mailing address of this Corporation shall be 211 Pacemaker Street, Orlando, FL 32809. The Corporation may change the location of its registered office and mailing address from time to time without amendment of these Articles of Incorporation.
