ARTICLES OF INCORPORATION  
of

I, the undersigned, hereby declare the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be: Dale Hodge, Inc.

The general nature of the business of this corporation shall be all lawful business activities permitted under the laws of the State of Florida and under the laws of the United States of America, without exception. 
