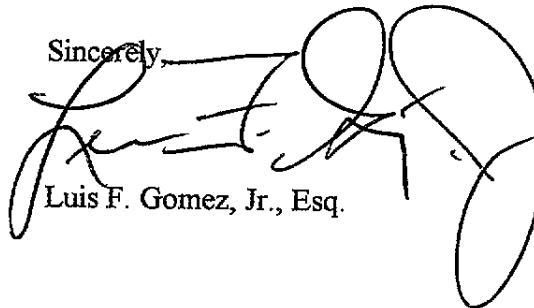

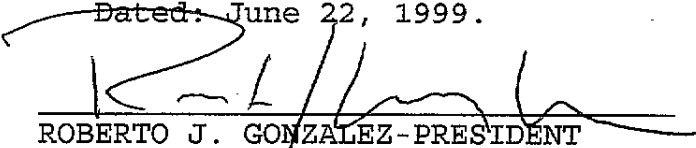
SIX: The period of duration of this corporation is perpetual.

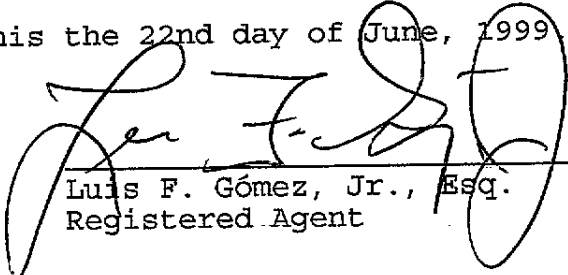
