Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts these Articles of Amendment.

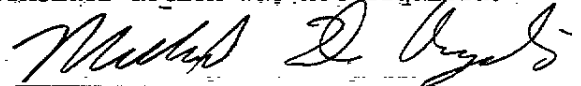
First: The name of the corporation is Adeptec Acquisition Corp.
