These Articles were approved by the shareholders of the corporation on September 10, 2012. The number of votes cast by the shareholders was sufficient for approval.

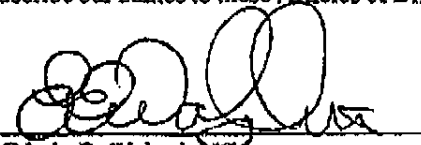
