ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of this corporation is Troy's Hauling, Inc.
- 2 <u>TERM</u>. This corporation shall exist perpetually.
