*Name.* The name of this Corporation is **ALL ABOUT FLOWERS OF GAINESVILLE, INC.**

Article II

*Principal Office.* The address of the principal office of the Corporation is 6500 S.W. Archer Road, Gainesville, Florida 32607

Article III

*Duration.* The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV
