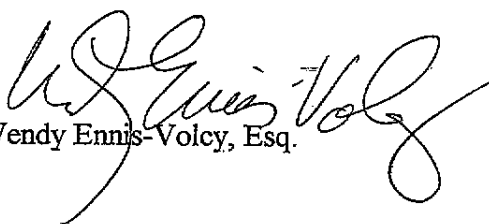

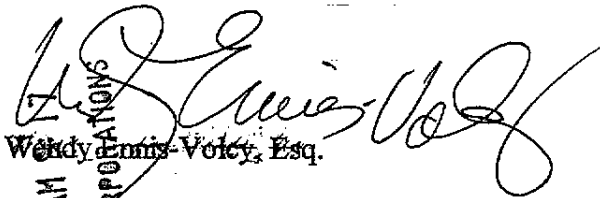

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

**FIRST:** Amendments adopted:

Prior Article I which states: "The name of the corporation is Concepts in Design, Inc. (Hereinafter called the corporation)" shall be changed to reflect:

Amended Article I - "The name of the corporation is **INTERIOR ARCHITECTURAL DESIGNS CORP.** (hereinafter called the "Corporation").

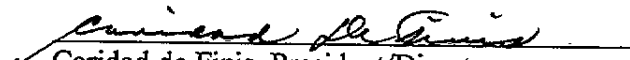

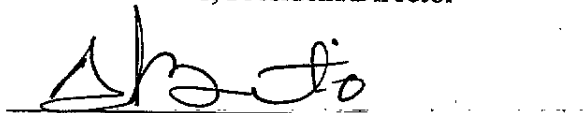
