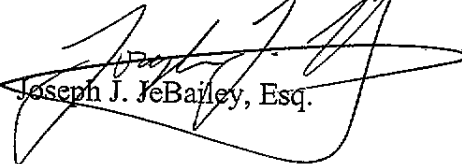

ARTICLE I - NAME

The name of this corporation is: **Team Linebacker, Inc.**
