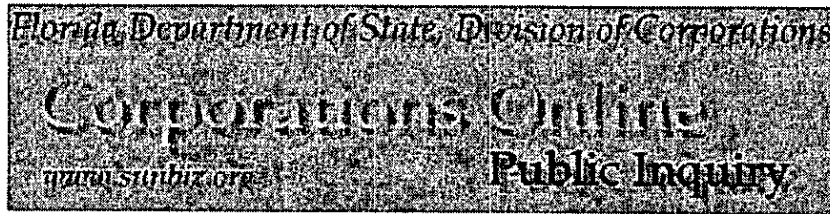
Please renew and activate the corporation. Since no UBR registration was received for us to renew, we also request that the penalty for renew be waived.
