## **RESTATED ARTICLES OF INCORPORATION WITH AMENDMENTS TO ARTICLES**

The sole shareholder of RICHARD C. KOMANDO, P.A., a Florida Corporation (P99000099695), who is licensed to practice law in the state of Florida, in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, does hereby restate the Articles of Incorporation of said corporation with amendments, as follows:

### **ARTICLE I. CORPORATE NAME.**

The name of this corporation is Komando & Associates, P.A.

### **ARTICLE II. PRINCIPAL OFFICE.**

The principal place of business and mailing address of this corporation are 629 Southeast Fifth Avenue, Fort Lauderdale, Broward County, Florida 33301.

### **ARTICLE III. CAPITAL STOCK.**

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100).

### **ARTICLE IV. REGISTERED AGENT AND OFFICE.**

The name and address of the registered agent is: RICHARD C. KOMANDO, 629 Southeast Fifth Avenue, Fort Lauderdale, Broward County, Florida 33301.

### **ARTICLE V. INCORPORATOR.**

The name and street address of the incorporator of these articles of incorporation is: RICHARD C. KOMANDO, 629 Southeast Fifth Avenue, Fort Lauderdale, Broward County, Florida 33301.

### **ARTICLE VI. DURATION OF CORPORATION.**

The duration of the corporation is perpetual.

## **ARTICLE VII. PURPOSE.**

The purpose of the corporation is to practice law. The sole and exclusive professional service to be rendered by the corporation is law.

## **ARTICLE VIII. SUBCHAPTER S LIMITATIONS.**

The aggregate number of shares which the corporation is authorized to issue is one hundred (100), and such shares shall be without par value. Such shares shall be of a single class, and all issued shares shall be held of record by not more than ten persons. Shares will be issued and transferred only to:

1. natural persons
2. estates, or
3. a trust described in 26 U.S.C. Section 1371 defining a qualified "small business corporation".

In addition, no shares shall be issued to or transferred to a nonresident alien.

## **ARTICLE IX. CORPORATE MANAGEMENT.**

The corporation shall have no board of directors, and all of the corporate powers shall be exercised by, and the business and affairs of the corporation shall be managed by and under the direction of, the shareholders.

## **ARTICLE X. QUORUM FOR TRANSACTION OF BUSINESS.**

The presence at any stockholders meeting, in person or by proxy, of persons entitled to vote all the shares of the corporation then issued and outstanding, shall constitute a quorum for the transaction of business.

## **ARTICLE XI. VOTING OF SHARES AND TRANSFERRABILITY.**

The affirmative vote of all of the outstanding shares of the corporation shall be the act of the shareholders. All of the issued and outstanding shares of the corporation shall be made subject to restrictions on their transferability by agreement among the holders of such shares.


## ARTICLE XII. RIGHTS AND POWERS.

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.


## ARTICLE XII. ACCEPTANCE OF DESIGNATION AS REGISTERED AGENT.
