**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF

These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of FIRST COAST PEDIATRICS, P.A., a Florida corporation (the "Corporation"), and in connection therewith, the undersigned officer, acting upon the authority of the Board of Directors of the Corporation, and upon authority of the holders of all of the shares entitled to vote on said amendment hereby sets forth as follows:

1. The name of this Corporation is FIRST COAST PEDIATRICS, P.A.
2. The Articles of Incorporation for this Corporation were filed on November 10, 1999 and assigned Florida Document Number P99000099733.
3. The Articles of Incorporation of FIRST COAST PEDIATRICS, P.A. have been amended by deleting Article I in its entirety and by substituting the following in lieu thereof:

"ARTICLE I - NAME

The name of this Corporation is CMES MEDICAL HOLDINGS, P.A."

In accordance with Florida Statute Section 607.1003, the referred to amendment was adopted by the Board of Directors of the Corporation on August 18, 2023 by unanimous written consent, and by written consent given on August 18, 2023 by the shareholders of the Corporation entitled to vote thereon in accordance with Florida Statutes Section 607.0704.
