

ARTICLE OF INCORPORATION
OF

ForeclosureCenter.Com, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is ForeclosureCenter.Com, Inc.

ARTICLE II: DURATION

The duration of the corporation is perpetual.

ARTICLE III: PURPOSE
