In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is FUTURO GROUP, INC.

ARTICLE II

The existence of the corporation shall begin on 11-3, 1999.

ARTICLE III

The street address of the principal office of the Corporation is 422 Lytton Circle, Orlando, FL 32824.

ARTICLE IV

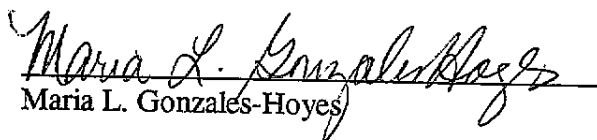

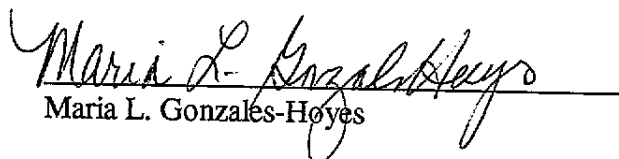
The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
