ARTICLE I

The name of this Corporation shall be: Sanlax Enterprises Inc.

ARTICLE II

Subject to the provisions of the laws of the State of Florida, especially Chapter 607, Florida Statutes and all other applicable laws, rules and regulations, this Corporation shall come into existence at 12:01 A.M. on August 31, 1999.

ARTICLE III

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The amount of capital stock authorized by this Corporation shall be (10,000) TEN THOUSAND at (\$1.00) ONE DOLLAR per share par value non-assessable Common Stock.

The Corporation shall have perpetual existence.
