

#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of this corporation is RESTAURANT CORPORATION OF AMERICA, INC.

### ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

### ARTICLE III - ADDRESS
