The undersigned subscriber to theses Articles of Incorporation is an individual competent to contract and does hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is: COMMISSIONING, INC.

ARTICLE II

The general nature of the business and the objects and purposes to be transacted by this corporation are:

- (a) To render consulting and commissioning services in the field of heating, air conditioning and any other field related to business endeavors performed by mechanical contractors, including but not limited to the installation, maintenance and repair of all things that are a part of or associated with any of these fields.
- (b) This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, The State of Florida, or any other state, county, territory or nation.
- (c) To own assets.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

One thousand (1,000) shares of common stock with a par value of 10 cents per share. Each share shall have one vote and when issued each share shall be fully paid for and shall be non-assessable.

ARTICLE IV

The corporation is to exist perpetually.

ARTICLE V


