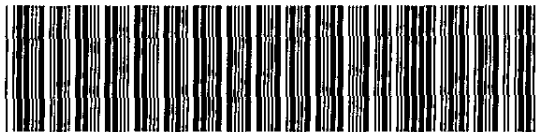

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of First Business Bank are hereby amended as follows:


FIRST: Article I of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The name of the corporation shall be Florida Business Bank and its place of business shall be 340 North Harbor City Boulevard, Melbourne, Florida 32935.

SECOND: The foregoing amendment was adopted by the holders of a majority of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, acting by written consent without a meeting as of October 21, 2004 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.


