# ARTICLES OF INCORPORATION OF WORTHY MANAGEMENT CORPORATION OF FLORIDA, INC.

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

#### **ARTICLE I - NAME**

The name of the corporation is:

#### WORTHY MANAGEMENT CORPORATION OF FLORIDA, INC.

#### ARTICLE II - NATURE OF BUSINESS

The general character or nature of the business to be transacted by this corporation is:

- a) Cleaning services; and
- b) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.

or such increase is offered for subscription or such bonds, notes, debentures, or other securities convertible into stock, are offered for sale, shall have the right to subscribe for the share of such authorized, but unissued stock, the shares of such new class of stock, the shares of such increased stock, or to buy such bonds, notes, debentures, or other securities, convertible into stock, before the same is offered for public subscription or sale, in proportion to the number of shares owned respectively by each of the holders of such stock.

#### ARTICLE V - TERM OF EXISTENCE

This corporation shall have perpetual existence.
