ARTICLES OF INCORPORATION ARTICLE ONE

SECRETARY OF STATE TALLAHASSEE, FLORIDA

VARADERO NATURAL HEALTH SYSTEMS, INC.

The name of this corporation is: VARADERO NATURAL HEALTH SYSTEMS, INC.

ARTICLE TWO

NATURE OF BUSINESS _==

This corporation may engage in any activity or business related that are permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY - OF STATE.

ARTICLE FOUR

CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

- A- Designation. The stock of this corporation shall be known as Common Stock.
- B- Authorized. The maximum number of shares of Common Stock that this corporation may issue is 100.
- C- Par Value. Each share of Common Stock shall have the par value of \$1.00.

In the absence of fraud in the transaction, the judgement of the Board of Directors as to the value of any such consideration shall be conclusive.
- E- Non-assessability. Each share of Common Stock shall be issued in exchange for consideration which is at least equal to the -- par value thereof, and shall be fully paid and non-assessable.
- F- Voting Rights. Each share of Common Stock shall entitle the -- record holder thereof to one vote upon each proposal presented at meetings of the stockholders of the corporation.

ARTICLE SEVEN

BY LAWS

The power to_adopt, alter, amend or repeal By-Laws shall be vested --either in the Board of Directors or the Shareholders, but the Board of

APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER

The approval of the shareholders of this corporation to any plan of -merger shall be required in every case, whether or not such approval is required by law.
