ARTICLE I

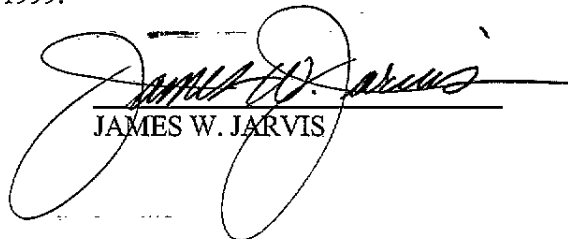

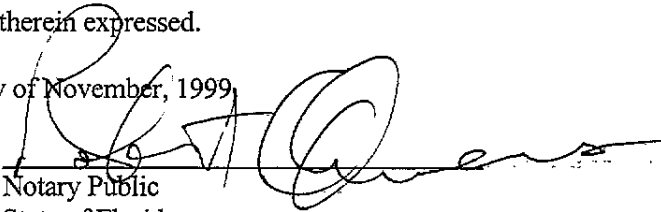

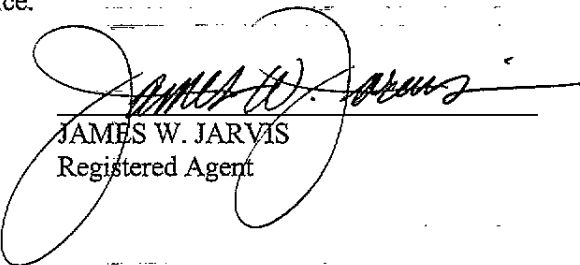
