ARTICLE I. NAME

The name of the corporation is OCTO-CLEAN JANITORIAL AND HOME MANAGEMENT SERVICES, INC.

ARTICLE II. PRINCIPAL OFFICE

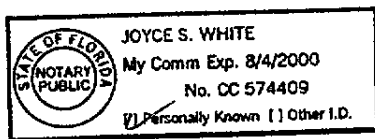

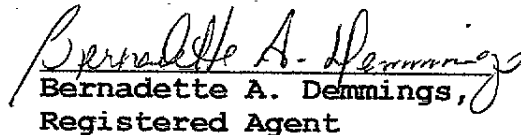
