ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is:

D&S TRANSPORTING, INC. OF FLORIDA

ARTICLE II - DURATION

The corporation shall have perpetual existence and shall commence upon the filing of these articles with the Department of State, Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.




