ARTICLES OF INCORPORATION OF CHESTNUT HILL TREE FARM, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

Article 1

Name. The name of this Corporation is CHESTNUT HILL TREE FARM, INC.

<u>Article II</u>

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 15105 N.W. 94th Avenue, Alachua, Florida, 32615.

Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

Article IV
