#### ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

## ARTICLE 1 \_\_\_\_ Name and Address

- Section 1.1 Name. The name of the corporation is Time Enhancers, Inc.
