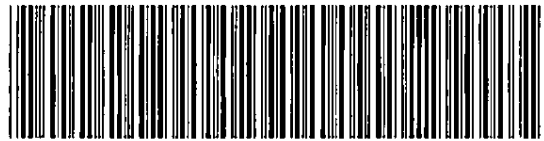

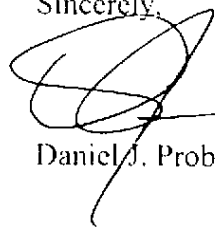

Item 1: The Officers and Directors of the Corporation are hereby amended as follows:

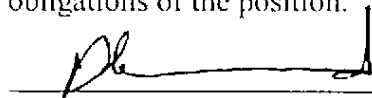

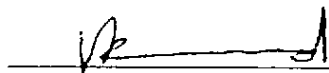
