

ARTICLES OF INCORPORATION OF DAVID J. HART HOLDING CO, INC.

The name of this corporation is DAVID J. HART HOLDING CO, INC.

ARTICLE II--DURATION

This corporation shall exist perpetually.

ARTICLE III--PURPOSE
