

### ARTICLES OF INCORPORATION.

#### ARTICLE I - NAME

The name of this corporation is Tyler's Home Child Safety, Inc.

### ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 5705 S.W. 114th Avenue Cooper City, Florida 33330

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

### ARTICLE IV - CAPITAL STOCK
