ARTICLE OF INCORPORATION

OF

Bird Community Development Group Inc

ARTICLE ONE

The name of the corporation is Bird Community Development Group Inc  
(The corporation's name must end with one of the following: Company, Corporation, Incorporated or an abbreviation thereof.)

ARTICLE TWO

The period of its duration is perpetual.  
(May be for a number of years or until a specific date.)

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.  
(Specific purposes may be stated.)

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 1000 of the par value of dollars (\$ 2.00 ) each.
