The undersigned, acting as incorporator of **LOCIN COMMUNICATIONS, CORP.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is **LOCIN COMMUNICATIONS, CORP.**

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE


ARTICLE VIII. BYLAWS


