OF

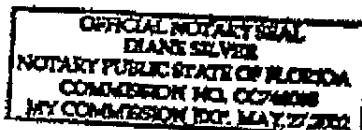


