The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the corporation is AC Wholesalers, Inc.
- SECOND: The purpose or purposes for which the corporation is organized are to engage in the transaction of any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
- THIRD: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000) shares of common stock having a par value of One Cent (\$.01) per share.
- FOURTH: The street address of the corporation's initial registered office is c/o 2665 South Bayshore Drive, Suite 901, Coconut Grove, Florida, and the name of its initial registered agent at such address is Barry S. Logan.
- FIFTH: The number of directors of the corporation may be fixed by the bylaws.
