This letter is to explain the delay in filing our UBR form with your office by the required due date. Our company did not receive the form in the mail from your office this year. I called your office to find out how to deal with this problem, and was told that you would send me the form. I was also told that I would be able to download the form from your web site.

I never received a copy of the form from your office, and at the time, my computer was not able to download the form from the internet. I had new software installed in my computer, and was finally able to download the form and submit the document to your office.
