#### ARTICLES OF INCORPORATION

OF

## FIVE STAR FLOWERS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

#### NAME

The name of the corporation is Five Star Flowers, Inc. and its address 3561 Moon Bay Circle, Wellington, Florida 33414.

#### ARTICLE II

#### DURATION

The duration of the corporation is perpetual.

#### ARTICLE III

#### PURPOSE

The general purpose for which the corporation is organized are:

- (1) To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
