ARTICLES OF INCORPORATION OF AVC OF TAMPA, INC.

In compliance with the requirements of Florida Statute 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I NAME

The name of the corporation is AVC of Tampa, Inc.

ARTICLE II NATURE OF BUSINESS

This corporation may engage or transact in any or all_lawful activities or business permitted under the laws of the United States, the State of Florida, or any other country, state, territory, or nation.

ARTICLE III PRINCIPAL OFFICE
