ARTICLES OF INCORPORATION OF LA FAMIGLIA, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be LA FAMIGLIA, INC.

ARTICLE TWO: DURATION: The term of existence of the corporation shall be perpetual.
