ARTICLES OF INCORPORATION

I, the undersigned, as a proper person acting as incorporator of a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation:

- FIRST** The name of the corporation is: **EVALUE LANDSCAPE, INC.**
- SECOND** The period of its duration is: **Perpetual.**
- THIRD** The purpose of the corporation is: **To engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.**
- FOURTH** The aggregate number of authorized shares is: **10,000 shares of common stock having no par value.**
- FIFTH** The corporation will not commence business until at least **\$100.00** dollars have been received by it as consideration for the issuance of shares.
- SIXTH** Cumulative voting of shares of stock is authorized.
- SEVENTH** Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: **Every shareholder, upon**

the sale for cash of any new stock of this corporation of the same class or series as that which is already issued, shall have the right to purchase a prorata share thereof at the price at which it is offered to others.

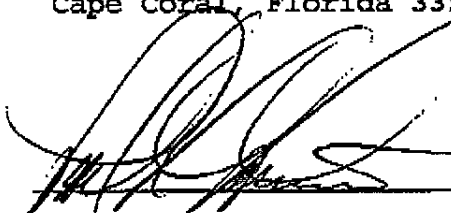
