The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I.
S CORPORATION ELECTION

The corporation elects to be taxed as a "small business corporation" for income tax purposes under the provisions of Section 1372, Internal Revenue Code, and the proper officers of the corporation are hereby authorized and directed to evidence such election by completing and filing Form 2553 of the United States Treasury Department, Internal Revenue Service.

ARTICLE II.
CORPORATE NAME

The name of this corporation is Casassa Corporation.

ARTICLE III.
ADDRESS OF CORPORATION

The address of the principal office of the Corporation, or the mailing address of the Corporation, if the principal office is not yet known, is 4280 East Tamiami Trail, Suite 204, Naples, FL 34112.

ARTICLE IV.
DURATION

The corporation shall have perpetual existence, commencing on the date of the execution and acknowledgment of these Articles or upon filing.

ARTICLE V.
PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE VI.

NUMBER AND CLASS OF STOCK

The corporation is authorized to issue one class of stock which shall consist of 100 shares of \$1.00 par value common stock, and which shall be designated "common shares".

ARTICLE VII.

PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of the corporation of the same kind, class, or series as that which he holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VIII.

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 4280 East Tamiami Trail, Suite 204, Naples, FL 34112.0, and the name of the initial registered agent of the corporation at that address is Mark Casassa. The officers may from time to time select and so communicate by appropriate notice to the Department of State, another registered office or registered agent or both.

ARTICLE IX.

INITIAL BOARD OF DIRECTORS
