

ARTICLES OF INCORPORATION OF

Sarasota Diagnostic Center, Inc.



ARTICLE I - NAME

The name of this Corporation is Sarasota Diagnostic Center, Inc.

ARTICLE II - PRINCIPAL OFFICE

The address of the Principal Office and Mailing address of the Corporation is 7416 Ridge Road, Sarasota, Florida 34238.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of engaging and conducting any or all lawful business of any nature, and doing all acts and things as are incidental to the foregoing or necessary or convenient to carry on the business of the Corporation or to effect or promote the purpose for which the Corporation is formed.

<u>ARTICLE IV – POWERS</u>

This Corporation shall have all the power enumerated in the Florida Business Corporation Act.

ARTICLE V - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of common stock with a par value of One Cent (\$.01) per share.

ARTICLE VI - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 2800 Tamiami Trail, Sarasota, Florida 34239, and the name of the initial registered agent of this Corporation at that address is Bart Price.

ARTICLE VII - INCORPORATOR

The name and address of the person signing these Articles is Bart Price, 7416 Ridge Road, Sarasota, Florida 34238.

ARTICLE VIII - BOARD OF DIRECTORS

This Corporation shall have not less than one (1) director. The number of directors may be increased or diminished from time to time in accordance with the Bylaws. The names and addresses of the initial directors of this Corporation are:

<u>ARTICLE IX – CUMULATIVE VOTING</u>

At each election for directors every shareholder entitled to vote in the election shall have the right to cumulate his/her votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the umber of his/her shares, or by distributing the votes on the same principal among any number of the candidates.

ARTICLE X - AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed to them by the Shareholders, and approved at a Shareholders' meeting by a majority vote of the stock entitled to vote thereon.
