

**ARTICLES OF INCORPORATION**

*The undersigned incorporator(s), being an corporation duly licensed to investment services, hereby form a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.*

**ARTICLE I. CORPORATE NAME.**




