ARTICLES OF INCORPORATION
of JEK Holdings, Inc.

Pursuant to Chapter 607 of the Florida Business Corporation Act, the undersigned incorporator hereby adopts these Articles of Incorporation for the purpose of forming a for-profit corporation.

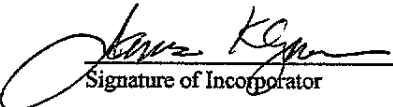
